

## A Dangerous Situation Arising: Part 2

### From 1900 to the End of This Age

#### *The Devils Are Released From Confinement: Demonic Control Expounds*

Insofar as man's innovative achievements are concerned the twentieth century stands alone. The twentieth century saw the start of a growth in technical knowledge unprecedented in the whole of mankind's previous 6000 year history. In just one century mankind progressed from the horse and cart to space travel, from wooden sailing ships to nuclear powered submarines, from wooden dolls to robots in the workforce, from the abacus to a Chinese computer having a capacity capable of over 33,000 trillion calculations per second: a number beyond human conception. Mankind's 6000 year history proves such a rate of technical development as this is abnormal. How did it happen, did the wheels of knowledge suddenly decide to spin out of control and why the twentieth century?

This abnormal growth in knowledge is unprecedented with one possible exception, the pre-flood era when the fallen Watchers taught mankind forbidden knowledge, as explained in Part 1 of this article. Could it be that the twentieth century was the time designated for the repetition of that which occurred in the first millennia of creation? Remember the future is in the past (Isa.46:10, Ecc.1:9). Let us go back and re-examine how YHWH dealt with the fallen Watchers,

*Again YHWH said to Rapha'el bind Aza'zel hand and foot, cast him into darkness; and opening the desert which is in Duda'el, cast him in there. Throw upon him hurled and pointed stones, covering him with darkness. There shall he remain forever; cover his face that he may not see the light. And in the great day of judgement let him be cast into the fire. (En.10:6-9)*

*To Miyka'el likewise YHWH said, go and announce his crime to Samyaza and to the others who are with him, who have been associated with women, that they might be polluted with all their impurity. And when all their sons shall be slain, when they shall see the perdition of their beloved, bind them for seventy generations underneath the earth, even to the day of judgement and of consummation until the judgment, the effect of which will last forever, be completed. Then shall they be taken away into the lowest depths of the fire in torments, and in confinement shall they be shut up forever. Immediately after this shall Samyaza, together with them, burn and perish, they shall be bound until the consummation of many generations. (En.10:15-17).*

Although all of the fallen Watchers were to be confined in the abyss, Samyaza, one of the chiefs of the fallen Watchers together with his associates, was bound only for seventy generations, after which they were to be released back into society. As shown below Scripture confirms that for some messengers, the abyss was only a temporary imprisonment and they were to be released at the end of this age. I have rearranged the verses from 2Thessalonians and Revelation to provide a clearer picture,

*For the secret of lawlessness is already at work – only until he who now restrains comes out of the midst. (2Thess.2:7).*

*And I saw a messenger coming down from the heaven, having the key to the pit of the deep and a great chain in his hand. (Rev.20:1).*

*And now you know what restrains, for him to be revealed in his time. (2Thess.2:6).*

*The beast that you saw was, and is not, and is about to come up out of the pit of the deep and goes to destruction. And those dwelling on the earth, whose names are not written in the Book of Life from the foundation of the world, shall marvel when they see the beast that was, and is not, and yet is. (Rev.17:8).*

Whilst these verses are referring to the release of the false Mashiach, Rev.17:12-13 tells us he will rule with ten associates (horns), thus we have confirmation that the abyss will be opened at the end of this age. Referring back to Enoch, we need to calculate a period of seventy generations and the Psalmist is of help,

*The days of our lives are seventy years; or if due to strength, eighty years, Yet the best of them is but toil and exertion; For it is soon cut off, and we fly away. (Ps.90:10).*

From this verse seventy generations will equal four thousand nine hundred years and we now need to fix this period to the calendar. We know it was Enoch who was told to inform the fallen Watchers of their impending punishment, and from the information contained in the tabulation below we can with some accuracy calculate when this was.

Enoch was 365 years old when he was taken up into heaven (Gen.5:23-24), thus this was 622 + 365 = 987 years from creation. Whilst in heaven Enoch was told to return to earth and inform the fallen watchers of their fate, so we can assume the imprisonment of the fallen Watchers was a little later, for arguments sake let's say it was around 1000 years from creation. This being the case the Watchers had spent 3000 years in imprisonment at Mashiach's Coming which was 4000 years from creation. This left 1900 years of imprisonment remaining after Mashiach. Thus the end of their seventy generations imprisonment was 1900 AD, the start of the twentieth century. Was it coincidence that no sooner had these devils been released that the world suffers two global conflicts (WW1 & WW2) taking life on an unprecedented scale? Add to this the abnormal rate of learning and the twentieth century stands alone in mankind's 6000 years of history. Was a single generation born with a different brain? I don't think so. The only rational answer is supernatural involvement: it was not mere coincidence that all this occurred immediately after HaSatan's devils were released from their confinement and back into society. The release of these devils as described in the book of Enoch is the only rationale to such an unprecedented rate of knowledge.

*Be sober, watch, because your adversary the devil walks about like a roaring lion, seeking someone to devour (possess). (1Pet.5:8)*

*Because of this rejoice, O heavens, and you who dwell in them! Woe to the earth and the sea, because the devil has come down to you, having great wrath, knowing that he has little time. (Rev.12:12).*

HaSatan's goal is to destroy YHWH's creation and he is running out of time, this being the case is he going to let his army of devils be idle? Mashiach warned of a heightened demonic presence at the end of this age and the evidence of this is all around us. With the release of these devils back into society the demonic situation is just as it was *'in the days of Noach*. Consider the following,

The evil spiritual situation existing in the 'Days of Noach;

1. The 1/3 of the messengers who fell with Lucifer
2. The Watchers who transgressed
3. The disembodied spirits of the pre-flood giants

The evil spiritual situation existing today

1. The 1/3 of the messengers who fell with Lucifer
2. The release of the fallen Watchers back into society from captivity
3. The disembodied spirits of the pre-flood giants

Only the second and third categories are terrestrial, the first category are most likely the entities described by the apostle in his epistle to the Ephesians,

*Because we do not wrestle against flesh and blood, but against principalities, against authorities, against the world-rulers of the darkness of this age, against spiritual matters of wickedness in the heavenlies. (Eph.6:12).*

These were the devils obstructing the archangel Gabriel from visiting Daniel (Dan.10:13). Of the terrestrial spirits Mashiach explained how the disembodied spirits travel around searching for a host body to occupy, when this happens we describe the person as under demonic possession. But the spirits released back into society from captivity have bodies and are not in need of a host and we know from their pre-flood cohabitation activities they are capable of transforming into human form: the apostle confirms how spiritual entities can achieve such transformation (Heb.13:2), therefore it would be naïve to doubt that HaSatan's demons are not amongst us today masquerading as humans.

A tangential comment:

Princess Diana never really integrated into the royal family but it is interesting that in a discussion with a friend she described the royals as not human, to quote her, "They are lizards and the queen mother is very much older than people think." There is a lot of material on the web about people transforming into a reptilian form: probably the most astonishing report, if any of this is to be believed, is that of Justin Bieber who allegedly changed appearance whilst in front of a crowd at an Australian airport. The incident was published in a Perth newspaper but almost immediately withdrawn - for obvious reasons.

The spiritual realm has powers far beyond those of the material realm and we must avoid naivety. We tend to think of demonic possession only in terms of extreme cases of evil/abnormal behaviour but we need to consider demonic possession with a much wider lens than in terms of isolated incidents requiring the attention of an exorcist. By demonic possession these devils control minds and hearts and are able to dictate a person's behaviour,

*Beloved ones, do not believe every spirit, but prove the spirits, whether they are of Elohim, because many false prophets have gone out into the world. (1John 4:1).*

But what is a false prophet? The Greek is (*prophētēs*) meaning inspired teacher, thus the verse is a warning to beware of leaders of society under the influence of 'false inspiration' which in terms of this article we may consider a euphemism for demonic possession. We are specifically warned of an increase in demonic activity in the end times,

*Now the Spirit speaks expressly, that in the latter times some shall depart from the faith, giving heed to seducing spirits, and doctrines of devils; (1Tim.4:1)*

HaSatan is an expert in covert infiltration and will target all those in positions of influence for his demons to control and his tentacles of evil have penetrated all walks of life: education, entertainment, science, technology, medicine, politics and religion. Although evil has penetrated all walks of life it is the experiments concerning artificial intelligence and genetic engineering which have the greatest sinister potential.

### **Artificial Intelligence**

If we needed proof of demonic control today we need look no further than the field of artificial intelligence. In a presentation at the World Economic Forum Yuval Noah Harari, a professor at the Hebrew University of Jerusalem said the following

- Simultaneous leaps forward in computer science and biology will bring human beings to the threshold of hacking life, allowing us to engineer both bodies and brains and create an economy in which data is the most important asset.
- The Infotech and biotech revolutions will give scientists the computing power and biological understanding to hack humans. The confluence of the two revolutions has already produced new technology.
- The result may be something that is not all together human and today's generation of Homo Sapiens could be the last truly human generation

Professor Harari is certainly not alone in his believe that the human race will, if current trends continue, cause its own extinction. Stephen Hawking, arguably the greatest physicist since Einstein, was of the same mind as Harari and in an interview with BBC News he voiced the same concerns,

*"Once humans develop artificial intelligence, it will take over and design itself at an ever-increasing rate. Humans, who are limited by slow biological evolution, could not compete and will be superseded."*

Professor Hawking says mankind is limited by slow biological evolution, is he not confirming that the explosion in technology in the twentieth century was beyond the rate of normal human learning and development? Biotechnologists are now mapping the brain in an effort to put the human aspect of consciousness, that is, the ability to think, into machines and to fuse the two together. With this fusion the machine will become more than just a machine, it will have a mind of its own with a mental capacity far more efficient than that of humans. We could define artificial intelligence as software having the ability to create, to write its own updates and constantly renew itself. Humanity will be replaced by a civilisation consisting of humanised computers or computerised humans (transhumanism), just as predicted by Professors Harari and Hawkins. Artificial intelligence has been described as the last invention mankind will ever make: Elon Musk describes artificial intelligence as summoning the devil, I doubt he realises the exactness of his words.

YHWH never intended for His humanity to replace itself with machines and if we are to believe our Scriptures, these mad scientists will not succeed but that it not the point. The point is, if YHWH never intended for artificial intelligence to enter His creation, and I believe He never proposed for humanity to attain this level of knowledge, who or what is directing an innovation having the potential to exterminate mankind, who would be the beneficiary? HaSatan! YHWH did not create us to be suicidal, therefore embarking on a course leading to self- extermination has to come from another source of control and that control is HaSatan via demonic spirits. It is HaSatan's desire to usurp YHWH's plans and the extermination of mankind is a huge step towards his goal.

It is inconceivable for a society with any level of integrity to allow a situation leading to its extinction, so how can we be facing this very situation? Innovation has always had an insatiable appetite for more and when this appetite is being fed by demons we have a runaway train that humanity has no ability to control. But HaSatan is also subtle and has used the gullibility of society to his advantage, ensuring only the benefits from this innovation are published, whilst the true potential and his ultimate goal remain hidden from society.

### ***Mixing Seed***

Consider the following comment from Jubilees concerning the pre-flood situation,

*And iniquity increased on the earth and all flesh corrupted its way, alike men and cattle and beasts and birds and everything that walks on the earth, all of them corrupted their ways and their orders, and they began to devour each other and iniquity increased on the earth and every imagination of the thoughts of all men was thus evil continually. And Elohim looked upon the earth and He beheld it was corrupt, and all flesh had corrupted its orders and all that were upon the earth had wrought all manner of evil before His eyes. (Jub.5:2-3)*

We are told that all flesh corrupted their ways **AND** their orders. This is a far reaching statement, to corrupt ones ways is to change ones habits and behave incorrectly but what does it mean to change ones order? Look what YHWH decreed for His creation,

*And Elohim said, "Let the earth bring forth the living creature according to its kind: livestock and creeping creatures and beasts of the earth, according to its kind." And it came to be so. And Elohim made the beast of the earth according to its kind, livestock according to its kind, and all that creep on the earth according to its kind. And Elohim saw that it was good. (Gen.1:24-25)*

The apostle provides a further comment,

*All flesh is not the same flesh, but there is one flesh of men, and another flesh of beasts, and another of fishes, and another of birds. (1Cor. 15:39).*

It is very clear that YHWH created all species and each type within a species to be unique: each had its own specific DNA and it was meant to remain that way. But when Jubilees says all flesh had corrupted its orders, is this a euphemism for cross breeding, for mixing seed? Is Jubilees telling us that by the time of Noach cross breeding had corrupted all forms of life? The book of Yasher affirms this was the situation,

*And their judges and rulers went to the daughters of men and took their women by force from their men according to their choice and the sons of men in those days took from the cattle of the earth, the beasts of the field and the fowls of the air and taught the mixture of animals of one species with the other in order therewith to provoke YHWH and YHWH saw the whole earth and it was corrupt, for all flesh had corrupted its ways upon the earth all men and all animals. (Ya.4:18).*

When we read the creation record it is clear that YHWH never intended a carnivorous creation, He decrees for all plants and the fruit of all trees to be for food for all living creatures and birds of the air (Gen.1:29-30) but by the time of Noah, creation had undergone a dramatic change (Gen.9:1-3). It was now a polluted creation in which the spilling of blood was commonplace. Was it the mixing of seed that produce hybrids having a carnivorous nature? It is hard to conceive that an Elohim of life would create such a blood thirsty monster as a tyrannosaur. This premise raises an interesting observation concerning the selection of the animals which were to be saved,

*And YHWH said to Noah, "Come into the ark, you and all your household, because I have seen that you are righteous before Me in this generation. Of all the clean beasts take with you seven pairs, a male and his female; and of the beasts that are not clean two, a male and his female." (Gen.7:1-2).*

We tend to associate this passage with the clean/unclean laws of Leviticus chapter 11 but such an association is clearly incorrect because later when disembarking from the ark YHWH tells Noah that every moving creature that lives is for food (Gen 9:3). The verses immediately following appear to confirm that all animals are for food provided their blood is drained from them: the only blood not to be spilt is human blood. So what is YHWH saying in the above passage? Clean is a translation of the Hebrew *Tâhôr* which means morally clean, pure, which I suggest would relate to what YHWH has created. Conversely the reference to unclean would refer to the impure hybrids created by an evil humanity 'mixing seed.' When we substitute pure and impure for clean and unclean the verse more accurately reflects the situation existing at the time of Noach. What is more the book of Yasher supports this interpretation stating that wolves were on board the ark: wolves are carnivores. What Scripture does not tell us, is how Noach was to discern which animals were pure and which were impure however, once again the apocrypha is helpful,

*At that time after the death of Methuselah, YHWH said to Noah, go you with your household into the ark: behold I will gather to you all the animals of the earth, the beasts of the field and the fowls of the air and they shall come and surround the ark. And you shall go and seat yourself by the doors of the ark, and all the beasts, the animals and the fowls shall assemble and place themselves before you, and such of them as shall come and crouch before you, you shall take and deliver into the hands of your sons, who shall bring them to the ark and all that will stand before you shall leave. (Ya.6:1-2)*

*Two and two came to Noah into the ark but from the clean animals and clean fowls, he brought seven couples. (Ya.6:9)*

It is clear from the book of Yasher that YHWH selected which animals were to enter the ark and although YHWH never intended for one species to cross with another, the presence of carnivore wolves on the ark prove He allowed, for whatever reason, hybrids to survive the flood, just which and how many we do not know.

It is clear from the above abstracts: Jub.5:2-3 and Gen.1:24-25, that mixing seed is abhorrent to YHWH, this being the case we know who is directing this technology. But HaSatan will not be content with destroying mankind only, he wants the ruination of all YHWH has created and with his army of demons he is making good progress in not only leading mankind towards total disobedience but using mankind for the gradual destruction of all YHWH has created.

Spirits are capable of manipulating matter irrespective of its physical form and the fallen Watchers wouldn't have needed laboratories to experiment with the DNA of all life forms. There is evidence via ancient cave and rock drawings these fallen messengers were mixing human and animal DNA. From the information we have, the corruption of DNA and the production of hybrid life forms was extensive by the time of the flood and Mashiach warned that it would be a parallel situation at the end of this age. The direction and rate of progress biotechnology is enjoying is proving Mashiach correct. Today we are approaching the same level of DNA corruption as what existed before the flood: through a process called CRISPR we now have the ability to read, write and edit all forms of DNA. Biotechnologists around the world are so obsessed with mutation that the experimentation with hybrids is penetrating all avenues of life: human, animal and plant: just as in the days of Noah *'all flesh had corrupted its order.'* The real danger is that we have no universal statutory standards of conduct controlling these experiments. All we can rely on is the moral conscience of the people behind the experiments but devils have no conscience.

Whilst researching for this article I came across this comment by Siddartha Mukherjee, an author who, in 2011 won the Pulitzer Prize in the general nonfiction category. I am not sure if the following comment is from the award winning book but it took my attention,

In the past four years or so (2012-2016), we have developed new technologies which allow us to manipulate, re-engineer and edit genomes (Genomes is the collective term for all genes together). We are at the stage where scientists are able to alter the human genome permanently, but we still don't know all the moral, ethical, and physical implications of that. One of the objectives of this book is to bring more people into this interesting discussion. For the first time in history we will be creating a new species of humanoids. It's, therefore, essential that all kinds of voices in the global community express their concerns, present their cases, and share their perspectives before we go down this road, as the process may be irreversible.

As with artificial intelligence, only the advantages of biotechnology are made public; cures for Alzheimer's disease, cancer, arthritis, MS, etc., whilst the sinister side of these experiments remains closeted.

Swapping human organs has been an acceptable surgical procedure for decades but only the efficacy of these operations ever gets publicised. When adverse reactions occur they are contained and restricted to medical journals only, so as to avoid any possible public outcry that may inhibit further innovation. Yet the effect of receiving a donor organ has, for some, had very dramatic effects on their lives. Gary Schwartz, a psychology professor at the University of Arizona, commenting on recipients of heart transplants says he has seen patients who displayed 'eerie similarities to the heart's previous owner.' Researchers at the School of Nursing at the University of Hawaii in Honolulu, sought to evaluate whether changes experienced by organ transplant recipients were parallel to the history of the donor. The parallels that were observed effected changes in food, music, art, sexual, recreational, and career preferences in addition to name associations and sensory experiences. The following are just examples of such changes,

1. A professional dancer received the heart of an 18-year-old man who had died in a motorcycle accident. She spoke about an interview she had with the press which was a few days after the operation. In the interview she was asked, "Since you have had this miracle what do you want more than anything in the world?" To which she replied, "I'd die for a beer right now." She said, "It just came out and I am not a beer drinker. I was mortified by the flippancy of the answer." She continued. "This was the first happening then little by little many things started happening until I really became convinced that I was living with the presence of another within me. There were the food preference changes; the first time they allowed me to drive I found myself going to a KFC for chicken nuggets, something I had never done or eaten before. My handwriting changed and other changes were sneaking up on me. After the surgery my old me has merged with the donor to create a third person."
2. Another example is that of an Australian woman who had a liver transplant which changed her blood group and resulted in her immune system adopting that of the donor. The doctors said it was as if she had received a bone marrow transplant.

These reports show that transplanting organs is the same as mixing seed, it creates a mutated DNA resulting in a changed personality, effectively a new person. These results should be a sufficient warning of the inherent danger of mutating DNA, even within the same species. Yet, mutation is the adrenaline of biochemists and has no boundary, species or other. In the eyes of YHWH mutation (mixing seed) is a transgression and a corruption of His creation. But this corruption is not wholly borne of mankind, as said in Jub.5:23 all flesh have corrupted their order and only YHWH knows the full extent of this corruption.

We have become creator which reminds us of the serpent's promise to Eve, "you will be like Elohim." But playing creator is a dangerous game. Unlike YHWH, we can neither foresee nor control what will be the result of continued DNA experimentation: we just wait for whatever eventuates and that is playing with fire. YHWH set a specific procedure for the creation of new life – copulation and copulation within the same species, by wandering away from YHWH's rules we become the servants of HaSatan, we become fused with his demons. HaSatan is in control and those involved in DNA experimentation, if not possessed themselves, are unwittingly working alongside a demonic presence in human form. If all this sounds far-fetched let me again remind you of the words of the apostle Paul,

*Be not forgetful to entertain strangers: for thereby some have entertained angels unawares.*  
(Heb. 13:2).

Whilst the apostle is talking in a positive sense demons have the same capability as YHWH's messengers to transform themselves into human form.

### ***Demonic Influence within the Entertainment Industry***

HaSatan has not missed the opportunity afforded from the influence the idols of music, fashion and film have over society, to progress his agenda. Occult signs and signals are commonplace amongst these idols; the hand signal for 666, the hand sign of the horns (although this has a variety of meanings, from a religious perspective horns are a figment of the devil) and the covering of one eye to portray the 'eye of Horus' are examples. Many song lyrics today promote evil and devil worship. These idols are either malignant spirits in human form or they are humans under demonic control via demonic possession.

These idols have become the trend setters for their followers and the influence they have over society is huge. It is an opportunity too good to miss and HaSatan does not miss opportunities. HaSatan is exploiting the magnetic attraction these idols enjoy, which in itself is idol worship, to channel occult messages to a completely oblivious audience. The covert channelling of evil is particularly insidious within children's cartoons, hardly any of which are without an occult content. Unfortunately most parents are ignorant of the subconscious effect of channelling and its potential influence on a child's mental and character development. Who is it who wants to brainwash young brains with evil, to portray evil as acceptable? Demons or demon possessed people are controlling entertainment with the aim of achieving a society in which evil is not so evil and YHWH's Torah is extinct.

Nowhere is demonic presence more obvious than in the area of illusion and magic. Today almost all magicians perform the impossible, defying the laws of science and nature. Levitation, body piercing without any trace of blood, walking up/down the face of buildings, passing through solid objects, morphing objects together and teleportation have all become the art of the magician. But performing the impossible is not magic, its sorcery and we know how YHWH feels about sorcerers,

*And I will come near to you to judgment; and I will be a swift witness against the sorcerers, and against the adulterers, and against false swearers, and against those that oppress the hireling in his wages, the widow, and the fatherless, and that turn aside the stranger from his right, and fear not me, says YHWH of hosts. (Mal.3:5).*

In his book 'Secret Teachings of All Ages' Manley P Hall, a 33<sup>rd</sup> degree mason and high ranking occultist says,

- It is possible to make contracts with spirits whereby the magician becomes for a stipulated time the master of an elemental being.
- True black magic is performed with the aid of a demonical spirit who serves the sorcerer for the length of his earthly life. Upon his death the magician becomes the servant of the demon.

One street sorcerer; Jibrizy openly confesses he sold his soul to the devil to do magic and when asked about the involvement of spirits in their performances, neither Dynamo nor Chris Angel denied such: Dynamo responded, "possibly." Whilst on a chat show this same sorcerer, referring to his act of walking down the side of a building, said it was the scariest thing he ever did. Why should he be scared if this is merely illusion and an act? Is it because they are not in control and they do not know if their performance will be successful because that is someone else's decision? These sorcerers are exposing their audiences to the influence of demonic spirits and ultimately HaSatan's seductive arm. What is alarming is that instead of being wary and rejecting those performing the impossible, audiences are so mesmerised they encourage the seduction by applauding the sorcerer.

Deuteronomy says the following,

*There shall not be found among you any one that makes his son or his daughter to pass through the fire, or that uses divination, or an observer of times, or an enchanter, or a witch, or a charmer, or a consulter with familiar spirits, or a wizard, or a necromancer. For all that do these things are an abomination to YHWH your Elohim: and because of these abominations YHWH your Elohim drives them out from before you. (Deut.18:10-12)*

The spiritual realm is boundless and limitless, possessing powers far beyond that of the natural realm, which is why YHWH placed boundaries between the two but HaSatan and his sorcerers are not concerned with YHWH's boundaries.

### ***Reconstruction of Satanic Monuments***

Who is it that is behind the reconstruction of a replica of the 'Palmyra Arch' which marked the entrance to the temple of Ba'al, built around 200AD in Palmyra, Syria. In 2018 this symbol of pagan worship also referred to as 'The Gate of Nimrod' was welcomed in America, Britain, Dubai and Italy before returning to its permanent resting place in Palmyra. The arch was erected in both London and New York to coincide with the feast of Molech: it stood in Trafalgar Square for three days and three nights illuminated in red, possibly to symbolise the blood sacrifices offered to this pagan god at this time.

The replica was erected for the opening of the World Government Summit that opened in Dubai. Based in the United Arab Emirates, the summit is an international organization for global dialogue where leaders in government, business, and technology discuss how governments operate and how policies are made. Why use a structure having satanic connections to inaugurate a meeting of the global influencing powers? Is this HaSatan confirming his control over 'his kingdom?'



At each unveiling of this pagan symbol audiences applauded and dignitaries gave triumphant speeches. We are living in a society that is oblivious to HaSatan's influence and obvious control. Remember the words of Isaiah,

*Woe to those who call evil good, and good evil; who put darkness for light, and light for darkness; who put bitter for sweet, and sweet for bitter! (Isa.5:20).*

There is a video titled 'Secrets In Plain Sight' it is a long video of nearly four hours but it is only necessary to watch the first hour to understand the story. This video proves world development is under the administration of demons: demons in the form of architects, alchemists, cartographers, astrologists, physicists etc. I must again refer to Heb.13:2.

### **Possible Further Demonic Activity**

Another phenomena of the 20<sup>th</sup> century was an unbelievable increase in the sightings of UFO's compared to any previous period in time,

Is it coincidence that such an explosion of UFO activity commenced immediately after the release of the devils from their confinement? You can decide for yourself. Personally I do not contribute to the 'we are not alone' syndrome insofar as it relates to galactic visitors from planets afar. My opinion is that the ET's or 'greys' as they are called, together with the UFO's seen in the skies, are nothing more than a further example of demonic activity. Spirits are certainly able to manifest themselves in any shape or form and possess a supernatural ability to control matter. Remember the second beast of Revelation 13 was able to bring fire down from heaven (Rev.13:13). Could the UFO phenomenon be a key phase in HaSatan's programme towards the ultimate deception to facilitate the acceptance of his false prophet? Today there is a growing trend towards a cosmic messiah under the auspices of a new world order and a single unified religion. Several of the pagan faiths, which will be party to this single religious body, are founded on a cosmic messiah. Today is merely preparation for tomorrow.

### **Conclusion**

For the last century society has been under the influence of two demonic entities; the release of the imprisoned spirits and the disembodied spirits of the pre-flood giants. Unfortunately the material realm has no natural defence to an attack from the spiritual realm: a supernatural attack requires a supernatural response. But supernatural help is only available from YHWH and regrettably this generation has rejected Him. Consequently, because there is no resistance to HaSatan's demonic army, the growth of evil within humanity is enjoying unbridled success. We have a generation living under the control of evil, a generation that has willingly or through apathy, sold its soul to the devil. Demonic possession is not sci-fi, it is not a creation from Hollywood it is real and today, as previously said, demonic possession has penetrated all walks of life.

Finally let us remember the words from the Psalmist,

*For YHWH shall build up Zion, He shall appear in His esteem. He shall turn unto the prayer of the destitute, And He shall not despise their prayer. This is written for a generation to come (H314), So that a people to be created (H1254) praise Yah. For He looked down from the height of His set-apart place; from heaven YHWH viewed the earth, To hear the groaning of the prisoner, To release those appointed to death. (Ps.102:16-20),*

Strong's H314 is the Hebrew (*achârôn*) which may also be translated last and H1254 is (*bârâ*) which may be translated selected or chosen.

As the Psalmist is referring to the end of time and the generation (people) that will be saved thus a more appropriate translation might be,

*For YHWH shall build up Zion, He shall appear in His esteem. He shall turn unto the prayer of the destitute, And He shall not despise their prayer. This is written for the last generation, So that a chosen people praise Yah. For He looked down from the height of His set-apart place; from heaven YHWH viewed the earth, to hear the groaning of the prisoner, to release those appointed to death.*

Whilst some would consider the environment we live in to be evil enough, what is awaiting us and lurking just around the corner, is far, far worse. Mashiach described the current situation in terms of 'birth pangs' and 'birth pangs' are a precursor to a greater pain to come. Today HaSatan is hiding in plain sight, we have his army of demons, these spawners of evil, not only living and breathing amongst us in society but in control of a society that is gullible, apathetic and asleep. It is an inept society completely ignorant of what it is doing, where it is heading and what is lying in wait for it. But we do not have to be part of such a generation; the essence of this article could be summed up with the adage 'to be forewarned is to be forearmed.' We must concentrate on our salvation, our destiny: our goal is to qualify for YHWH's remnant and a blessed life in the Land. That being the covenant Land not the geographical Israel of today. Let us make sure we are part of that last generation spoken of by the Psalmist.
